Annual Membership Dues Agreement

This document outlines the terms, conditions, and benefits associated with the Hampton Racquet Annual Membership for the 2025 season. By becoming a member, you will agree to adhere to the following policies:

1. Annual Dues/Membership Fees & Perks

- All members, including those previously grandfathered in or NAOA members with perpetuity arrangements, are required to pay the annual dues for the 2025 season.
- Annual dues should be paid prior to the start of the season.
- Both annual dues and the initial fee (if applicable) must be paid for each summer/season to maintain membership.
- The club no longer has any connection with NAOA.

- **Membership Fees:**
 - Annual Dues:
 - \$3,000 for individual memberships.
 - \$6,000 for a family membership (up to 4 people).
 - Initial Fee (for first-time members):
 - \$12,500, required for those who have never been part of Hampton Racquet Community. (*First Time Player*)
 - Initiation fees can be paid upfront or over three years.

- **Payment Terms:**
 - Both the annual dues and the initial fee (if applicable) must be paid for each summer/season to maintain membership.

As a member, you will enjoy the following complimentary perks:

- **Intro Clinics:** Each member has access to a complimentary introductory clinic in the following racquet sports:
 - Padel
 - Pickleball
 - Beach Tennis
 - Tennis

- **Wellness Classes:** Each member can enjoy one group Pilates mat class or yoga class at the start of the season.

- **Members have access to the Wellness amenities.**

1. Guest Eligibility

- **Guest Allowance:**
 - As an Individual Member, you will receive 5 guest passes for the entire summer.
 - As a Family Member, you will receive 10 guest passes.
 - Guest passes are non-transferable.

- **Additional Guest Access:**
 - Once you exceed your allocated guest passes, additional guests must pay \$100 per day to access the club, including lessons and amenities.

- **Guest Pass Distribution:**
 - Guest passes will be issued via email or provided as guest cards upon membership sign-up.

- **Guest Booking and Rental Policy**
 - Guests are allowed to book courts or access clinics only 24 hours prior to the day they wish to play.
 - This policy ensures that members are given priority for bookings and access to the club's facilities.

3. Food & Beverage (F&B) Credits

- **Credit Amounts:**
 - \$300 credit in the restaurant/café for each individual membership.
 - \$600 credit in the restaurant/café for each family membership.

These credits are included with the membership and can be used throughout the season.

4. Lessons and Rentals

- **Membership Requirement:**
 - To rent courts, book lessons, or participate in clinics, individuals must either be members or registered guests of a member.

5. Kids Camp Policy

- **Guest Access for Parents and Families:**
 - While a child is enrolled and attending the Kids Camp, the entire family will be considered guests of the club and will have access to the club's amenities, including lessons.
- **Additional Details:**
 - Both parents are allowed access during the child's camp attendance.
 - If the family has additional children who are not enrolled in the camp, they are also welcome as part of the family's guest access during the camp period.
- **Guest Policy Limits:**
 - This access applies only during the duration of the enrolled child's participation in the camp. Specific limits or restrictions are outlined in this agreement to avoid confusion.
